The Institute for Stem Cell Science & Regenerative Medicine ([www.instem.res.in](http://www.instem.res.in)), Bangalore is an autonomous institute of the Department of Biotechnology, Ministry of Science & Technology, Government of India. DBT-inStem's mandate is to establish collaborative research programs in the field of stem cell biology, regeneration and repair in development and disease, with translational emphasis. To develop strengths in focused areas, research at DBT-inStem is driven through collaborative inter-disciplinary themes, addressing questions that are beyond the scope of a single laboratory. DBT-inStem shares a campus and research facilities with the Bangalore Life Sciences Cluster ([BLiSC](#)).

**Position Details:**

The position involves management and coordinating operations of the Stem Cell Facility. The Head of the Stem Cell Facility is expected to manage the space and train users from within the campus (and outside) in various aspects of cell culture and stem cell related experiments. Responsibilities include (but are not limited to): coordinating activities and maintenance of the stem cell laboratories, maintenance and distribution of cell lines and reagents providing training in the generation and use of stem cell lines and cell-based disease models, including genome-editing. Organization of training workshops will be a core responsibility.

An integral component of this position is the continual updating of standard operating procedures that govern the work carried out in the stem cell facility and ensuring that all users strictly adhere to these policies. Additionally, the incumbent of this position will ensure that the facility meets (if not exceeds) the statutory requirements regulating work with human stem cells.
