### **Position Details:**

The position involves management and coordinating operations of the Stem Cell Facility. The Head of the Stem Cell Facility is expected to manage the space and train users from within the campus (and outside) in various aspects of cell culture and stem cell related experiments. Responsibilities include (but are not limited to): coordinating activities and maintenance of the stem cell laboratories, maintenance and distribution of cell lines and reagents providing training in the generation and use of stem cell lines and cell-based disease models, including genome-editing.
