

### **Important instructions to Shortlisted candidates**

<b>Verification of Documents</b>	All eligible candidates are required to carry with them valid photo ID proof for verification. All documents in support of age, category, qualification, and experience shall be verified. Candidates must bring all original documents for verification along with one set of self-attested documents (photocopy). Only those candidates who will clear verification shall appear for the interview.
<b>Call Letter</b>	Call Letters for an interview shall be sent through email to the eligible candidates at the email ID provided in their application along with the date and time of the interview, tentatively planned in <b>3<sup>rd</sup> week of November 2023</b> . In case any candidate, whose name appears on the short-list, and has not received the call letter, he/she may appear for the same at the venue at the stipulated time on the given date along with a photo identity proof of name & address.
<b>Traveling Allowance/Stay</b>	No TA/DA will be paid for appearing in this interview. Candidates have to make their own arrangements for stay/food etc.
<b>NOC from employer</b>	Candidates working in Govt./Govt. undertaking/autonomous or statutory body/university etc should bring a ' <b><u>No Objection Certificate</u></b> ' from their employer and produce the same at the time of the interview.
<b>Disqualification of a candidate</b>	The applicants shortlisted for the interview are purely based on the information provided by the candidates in the application form through the online portal. In case any candidate fails to produce any certificate/testimonial/mark sheet in support of his/her qualification, age, experience, and category declared by him/her, or fails to furnish a 'No Objection Certificate' from his/her employer, wherever applicable, the candidature of the incumbent will be canceled. He/she will not be allowed to further participate in the selection process.
