

Important instructions to Shortlisted candidates

Verification of Documents	All eligible candidates are required to carry with them valid photo ID proof for verification at the test venue. Candidates must bring all original documents for verification along with one set of self-attested documents (photocopy) at the time Skill Test. Only those candidates who will clear verification shall appear for the Skill test.

Call Letter	Call Letters for a Written Test shall be available on the website(https://www.instem.res.in/jobportal/) for download and intimation will be sent through email to the eligible candidates at the email id provided in their application along with the date and time of the written test, tentatively planned on 18 or 25.02.2024(Sunday) in Bangalore Only . In case any candidate, whose name appears on the short-list, and has not received the call letter, he/she may appear for the same at the venue at the stipulated time on the given date along with a photo identity proof of name & address.
Traveling Allowance/Stay	No TA/DA will be paid for appearing in this written test. Candidates have to make their own arrangements for stay/food etc.
NOC from employer	Candidates working in Govt./Govt. undertaking/autonomous or statutory body/university etc should bring a ' No Objection Certificate ' from their employer and produce the same at the time of the Skill Test, which will be conducted for the shortlisted candidate according to the selection pattern on a later date.
Disqualification of a candidate	The applicants shortlisted for the written test are purely based on the information provided by the candidates in the application form through the online portal. In case any candidate fails to produce any certificate/testimonial/mark sheet in support of his/her qualification, age, experience, and category declared by him/her, or fails to furnish a 'No Objection Certificate' from his/her employer, wherever applicable, the candidature of the incumbent will be cancelled. He/she will not be allowed to further participate in the selection process.
