

TERMS AND CONDITIONS

- 1. The job shall have to be performed in accordance with the standard test methods prescribed in IS/APHA and presenting, interpreting the actual results in comparison with the IS: 10500/2012.
- 2. In the event of any dispute the followings shall be the order of priority to decide the issue:
 - a. Schedule of quantity
 - b. IS / APHA methods/specifications
 - c. Instructions of Engineer In charge.
- 3. Before quoting, service provider shall fully understand the locations of sample collections, parameters and number of parameters to be tested etc. No additional claim whatsoever shall be entertained by the department during the contract period.
- 4. The quantities shown in the schedule are tentative and may change as per institute demand.

 The Contractor shall not claim anything extra on this account. The payment shall be made as per actual quantities and as per the conditions of the contract
- 5. All precautionary measures should be adopted for the safety purposes for any accident during the collection of samples, testing and the service provider shall be overall responsible for the same.
- 6. After the award of service, if the agency / laboratories fail to start the work, the laboratories/agency will be debarred for a period of three years to participate in the tender/quotation for inStem works.
- 7. The contractor along with their quote shall submit GST, PAN, accreditation and Experience Certificate of firm and any other relevant documents or requested by the institute. The agency failing to submit requisite proof/documents will be rejected.
- 8. Performance security:
 - a. Within 10days of receipt of Letter of acceptance (LOA) from the institute, a performance guarantee at the rate of 3% of tendered value to be submitted in the standard format of the institute.
 - b. Security Deposit shall be deducted @ 2.5 % from each bill of the successful service provider and shall be released 06 months after date of completion of contract.
- 9. Rates shall be inclusive of all taxes (excluding GST), cess and levies and no extra shall be payable in this regard. The GST shall be indicated at the last of the schedule of quantities.
- 10. . Deductions from Bills:
 - a. TDS-IT @ 1% or as per the prevailing rate or as per amendment issued by the GOI.
 - b. TDS-GST@2% or as per the prevailing rate or as per amendment issued by the GOI.
