### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

The purpose of the work is maintenance of the high-end electron microscope with comprehensive coverage for both parts and service.

The Titan Krios G3i is a high-end electron microscope that has automated sample exchanger and direct electron detectors. The EM is part of National facility and has been used extensively by users across India. As the instrument has a lot of parts and are quite expensive to replace. The comprehensive maintenance contract covers the parts as well as service by the vendor. The CMC also allows for fast service (in 2-3 days) and the parts to be delivered from Europe or Singapore in 3-4 days including customs clearance. Due to the high cost of the downtime, CMC is a requisite for this high-end instrument.

1) Service to be carried out within 2-3 days upon reporting of the fault.

2) If a part needs to be replaced, then the part be ordered and delivered in 3-5 days.

3) Preventive maintenance of the instrument and calibrations to be done every 6 months.

4) The accessories for the main instrument (Krios) including Vitrobot, chiller included in the maintenance contract.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
