1. A security deposit @ 3% of the contract value shall be provided by the Co ntractor within 15 days of awarding of Contract.

2. The Contract will be initially for a period of ONE year with a provision of one-year extension subject to evaluation of the performance of service prov ider/Contractor by INSTEM before end of first year contract. The performan

ce of the service provider/Contractor will be evaluated every Three Months on a continuous basis and the extension /renewal of contract will be based on performance evaluated by INSTEM.
