1. GUARANTEE/WARRANTY

The item/s covered under this tender shall be subject to a guarantee for trouble fre e performance, workmanship, material etc., fulfilling the specifications mentioned in this te nder for **12 months** from the date of commissioning.

2. PERFORMANCE B/G

The successful bidder shall have to execute a performance B/G in accordance with the guarantee/warranty for 5% value of the order. This B/G has to be executed on an appropriate value of stamp paper in terms of a bank guarantee drawn on any Nation alized Bank and shall remain valid till the completion of the Defect Liability period/warranty period, with **6 months** claim period.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
