1. The system should be of a Convection type oven.
2. The system capacity should be 40 Litres.
3. The system should have control type of Touch key pad (Membrane).
4. The system should have control panel with the option for 4 char Display and other option like Cooking time, Kitchen Time, Standing time etc.
5. The system should have temperature ranging from 110°C to 200°C.
6. The system should have display settings for the timer ranging from 99 min 99 seconds.
7. The system should have Child lock features.
8. The system should have cavity material made up of Stainless Steel.
9. The system should be equipped with the required safety features to operate and Short circuit protection system.
10. The system should have features for child lock, Turbo defrost, Keep warm, Quick 30 sec, Auto Re-heat, Auto cook options.
